### Why this form?

With this form people can submit an application for a certificate of admission by operation of law (section 3 of the Admission and Expulsion Act (WTU-BES)). Fill in one form per applicant.

### Who qualify for a certificate by operation of law?

The following foreign nationals or Dutch nationals are admitted to the public bodies by operation of the law pursuant to section 3 of the WTUBES):

- a. posted by government agencies, as long as they are in the civil service;
- b. those who have been employed by a public body and for that reason receive a pension or benefit by way of a pension and unremarried widows of such foreign nationals;
- c. professional consuls, professional consular officials and other consular personnel admitted as such in public bodies;
- d. members of the armed forces, for the time that they are posted in the public bodies;
- e. crew members of ships or aircraft that are part of the navy or air force of any nation for the time that the public bodies are subject to the permission of the competent authority;
- f. the spouse not legally separated and minor children of the persons mentioned under a, b, c, and d;
- g. born in a public body, provided that they have reached the age of sixteen and have been admitted to the public bodies without interruption since their births:
- h. Dutch nationals as referred to in section 1a of the WTU-BES, who are of age and meet certain conditions (Certificate of Good Conduct, accommodation and sufficient means of support);
- i. minor children of the Dutch nationals mentioned under h, if one of the parents has parental authority.

### What happens to your application?

If you have submitted your application in person at one of the offices of the IND Caribbean Netherlands Unit (see the visiting addresses below) and your application is complete, your application will be processed. If your application is not complete, it cannot be assessed. You will receive a notification in writing when a decision has been made on your application.

\*Depending on the country the deed must be legalised by the Dutch embassy in the country of origin or be provided with an apostille stamp. If the deed has been drawn up in a language other than Dutch or English, a translation of the deed made by a reliable translator must also be added.

### Dutch nationals as referred to in section 3(5) and (6), of the WTU-BES:

- (12 years and older and when you have also lived outside the Kingdom of the Netherlands the last five years): copy \*legalised certificate of good conduct, for the last five years, issued by the competent authority where you have lived for the last five years (not older than 3 months on date of application):
- proof of accommodation in the public bodies;
- proof of independent, sustainable and sufficient financial resources;

#### If employed:

- employer's declaration (MBES29) + copy valid passport/identification employer; or
- a valid work contract;

### if self-employed:

- (in case of a company): business/corporate permit, issued by the Executive Council;
- excerpt from the trade register from the Chamber of Commerce (not older than 6 months on date of application);
- recent bank statement with minimum of USD 20.160;
- the company's crib number, issued by the Tax Inspectorate;

### People of independent means:

• declaration by a bank which states the amount of the interest received (minimum USD 20.160 annually) on the account(s) in the name of the applicant;

## Pensioners

· declaration or letter from the pension fund which shows the amount and term of the pension benefit received;

### Trainee or apprentice

- trainee agreement which mentions the trainee compensation; and/or
- declaration of study allowance (minimum 50% of minimum wages); and/or
- $\bullet \ bank \ statement \ showing \ that \ you \ have \ sufficient \ financial \ resources \ during \ the \ course \ of \ the \ trainee- \ or \ apprentices hip$

### Children as referred to in section 3 (6) of the WTU-BES, also:

- copy \*legalised birth certificate of each child (not older than 1 year on date of application);
- if applicable: proof showing that one of the parents referred to in the fifth paragraph has parental authority;

### If one of the parents does not come along to the public bodies:

- copy valid passport of the parent who is staying behind;
- permission statement of the parent staying behind (MBES25);
- if the parent who lives in the public bodies has sole parental authority: copy \*legalised order granting this .
